








What We've Been Doing cont.

- Conducting a detailed review of extensive work done to date with Task Force:
 - Draft Community Character & Vitality Report
 - Draft Grant Road District Zoning Ordinance





What We've Been Doing cont.

- Identifying possible options for going forward, taking into consideration
 - Existing plans in corridor area, including Area Plans and Neighborhood Plans
 - Lessons learned from overlays adopted for other areas of City since Grant Road Improvement began (Infill Incentive District and Main Gate Overlay District) and from previous corridor planning work done (Oracle Rd. and Stone Ave.)
 - Establishing model approach that can be applied to other RTA corridor projects



Tonight's Focus: Recommendations for Moving Forward

- Request Mayor & Council <u>adopt corridor</u> <u>vision</u> depicted in Draft Community Character & Vitality Report, with minor modifications.
- 2. Achieve vision through development and implementation of <u>land use</u> planning tools, including an overlay and other tools in phases timed with roadway design.
- 3. Have <u>Task Force continue</u> to review roadway design, and form a <u>Land Use Subcommittee</u> of the Task Force to advise on overlay and other land use planning tool development and implementation.

Recommendation for Task Force Consideration

Recommend that Mayor & Council adopt Grant Road Corridor Vision based on the Draft Community Character & Vitality Report, with modifications to streamline and update process, address dated information, enhance maps for readability, and remove some detail to create policy-level document.





Rationale for Adopting Corridor Vision

- Corridor vision never formalized through adoption
- Offers a cohesive image for corridor
- Establishes a framework and principles to guide development and implementation of overlay and other land use planning tools.
- Provides policy-level, rather than specific-parcel-level, guidance to avoid conflict with area and neighborhood plans.
- Can be achieved relatively quickly through Mayor and Council adoption.

<u>Note:</u> Precedents include (1) Stone Avenue Measures for a Livable Corridor and (2) the Oracle Area Revitalization Project.

Vision Adoption Steps & Est. Schedule (2015)

- If Task Force recommends adoption of Grant Road Corridor Vision Today, then following would apply:
 - Staff modifies Community Character & Vitality Report as proposed and emails to Task Force for review and comment – <u>By April 10 for two-week review period</u>
 - Staff reviews Task Force comments and makes any additional modifications needed - <u>By April 30</u>
 - Staff makes modified report available on-line and in Ward Offices and notifies public through Grant Road contact list and other means, and staff and Citizen Task Force members meet with any interested groups - <u>By May 4 for three-week review period</u>
 - Staff reviews comments for any additional modifications prior to submitting to Mayor & Council - <u>By June 1</u>
 - Mayor & Council reviews and decide whether to adopt vision -June 23



Phased Approach to Development & Implementation of Land Use Planning Tools Original Approach, Recommendation, Rationale, Est. Timeline



Recommendation for Task Force Consideration

- Proceed with a phased approach to developing and implementing land use planning tools.
 - Land Use Planning Phases would be based on roadway design phases:



- Land use tools would include:
 - overlay
 - possible regulatory changes
 - property disposition strategies
 - economic incentives



<u>Recommendation #2</u> *Rationale*

- Achieving Corridor Vision will require multiple tools and strategies.
- Undertaking development and implementation of land use planning tools for full 5-mile corridor is not manageable due to complexity, would take longer, and may be more likely to get derailed due to controversy.
- Looking closely at smaller segments of the corridor will allow for well considered decisions regarding what is needed to achieve the Corridor Vision in that segment, and whether or not any Area or Neighborhood Plan amendments need to be pursued.
- Timing land use tools with roadway design means we will have greater certainty about remnant parcels and redevelopment sites to ensure on-the-ground land use challenges are being addressed and opportunities are being pursued.

Task Force Role & Schedule Going Forward

- Task Force stays in place as constituted to weigh in on roadway design at appropriate times for each of the remaining phases. Assumption is that full Task Force would meet 2 – 4 times per year for the next 2 years.
- Land Use Subcommittee of the Citizen Task Force is formed to advise on overlay and other land use planning tools. Meeting frequency would range from monthly to quarterly for the next 2 years and would include members attending neighborhood meetings and Planning Commission.



Recommendation #3 Rationale

- Provides continuity in process from design initiation through design completion
- Provides ongoing citizen advisory body to weigh in on roadway design for each project phase, taking into account Design Concept Report
- Offers a forum for public comment as project roadway design moves forward
- Provides subcommittee option for Task Force members particularly interested in land use planning and available to meet more frequently, recognizing that neighborhoods and Planning Commission will play a large role in the Land Use Planning process.
